



# CITY LIGHTS 2016 ANNUAL FALL JURIED SHOW

Artists are invited to enter their original artwork in a juried competition at **City Lights Art Gallery, 3 E Army Street, Henderson NV 89015** during the month of October 2016.

Judging will take place the first week of October and over \$1,300.00 will be awarded. Accepted entries will be displayed at City Lights Art Gallery for the month of October.

Prizes will be awarded in 6 categories: Watercolor, Oil, Acrylics, Pastel/Drawing, Photography and Other Media (to include collage, encaustic, 3-dimensional works, etc.). A Best of Show will also be awarded. Two judges will jury the show, one for Photography, Linda Hicks, and one for all other categories, Regina Marvin.

An Artist Reception will be held on Saturday, October 8th from 2 to 5pm at City Lights to announce the winners.

All entries must be original and done by the submitting artist. City Lights Gallery requires a Certificate of Authenticity (CoA) for each piece of artwork submitted. City Lights' CoA is attached for your convenience, or you may use your own. All artwork must be wired and ready for hanging (no saw tooth hangers are allowed). An attachment is provided to assist you in preparing your artwork for hanging. Gallery wrapped canvas works with painted edges are acceptable. A size limit of 1,100 square inches for each framed work will be strictly enforced (measured from outside edges of the frame).

The 2016 Fall Juried Show is especially exciting for City Lights this year as we begin an online entry process using **CaFE™ CallforEntry.org** (a non-profit organization associated with the Western States Arts Federation). **This is new to City Lights entrants, so our traditional method of submission will also be accepted.**

## Directions for use of CaFE™:

There is **NO CHARGE** to the Artist for the set-up and use of an account in **CaFE™**, plus you will have the benefit of being notified of numerous competitions across the country (including ours) that you can easily submit to. Once your account is set up and JPEG images of your artwork are uploaded, entering the City Lights Juried Show is just a few clicks away! Setting up your artist account may be done ahead of time by visiting [callforentry.org](http://callforentry.org). If you want assistance in doing this the first time, please contact Libby Chan. She is willing to meet with you and assist in setting up your account any time prior to the cutoff

For those who require assistance in taking and uploading jpg images to the CaFE™ website, we are grateful that several photographer members will be at the Gallery on September 15<sup>th</sup> and 17<sup>th</sup> to assist. Any art to be photographed must be brought to the Gallery on those dates and must be UNFRAMED. Please bring a thumb/flash drive so you will have the images to load into CaFE™ and take home for your own files.

If you want assistance creating your account and/or uploading the files on those specific dates, Chris Mazglad and Libby Chan will be available to help.

If you enter online, you will be notified that your entry has been accepted for the exhibit by September 22<sup>nd</sup>. **All accepted Entries must be physically at City Lights Art Gallery by October 1<sup>st</sup>. Those who wish to submit their art the traditional way may drop off their submissions at the Gallery on Friday, September 30<sup>th</sup> or Saturday, October 1<sup>st</sup> during normal business hours (10am to 4pm).** Submission Forms are attached. Entrants must sign a Hold Harmless Agreement when art is delivered to City Lights Art Gallery. The City Lights Art Gallery Hold Harmless Form is attached. In order to expedite the check-in process, we suggest that all forms are completed and attached to your artwork along with the CoAs when you come in.

Please note that due to gallery space limitations, the possibility exists, that not all art submitted will be accepted. For art submitted through our traditional process, artists will be advised by October 3<sup>rd</sup> if any of their entries have not been accepted. Entry Fees are not refundable.

**City Lights General Members will receive a \$10.00 Coupon for 2<sup>nd</sup> and 3<sup>rd</sup> entries in their email.**
